2022/2023 SERVICE CONTRACT

I hereby by agree to breed my mare _____ Reg.: _____
during the 2022/23 season to the stallion GRANITE owned by Quartz Hill Syndications.

1. SERVICE FEE.

The Service fee payable is \$1850 (GST Inclusive) which includes a non-refundable booking fee of \$330. The booking fee is payable upon execution of this contract.

The booking fee is non-refundable and is deducted from the service fee. The balance of the service fee is payable upon 45 days positive pregnancy test. A Certificate of Service will not be sent out till payment is received.

This service fee does not include semen collection, semen freight and any other costs incurred at the property where the mare is served.

2. CHARGES.

The Owner agrees to pay all charges incurred for semen collection and semen transport. Please contact us for semen collection charges and transport fee.

3. FREE RETURN

The mare is entitled to a free return to GRANITE if the foal dies within 30 days of foaling or if the foal is stillborn, in both cases a report certified by a practicing Veterinary Surgeon is required within 7 days.

The Free Return is to be used with in 2 years.

4. Embryo Transfer

If this mare is to be embryo transferred and more then one foal results from any one embryo flush, an additional stallion service fee will be due and payable upon each successful healthy live foal born.

5. Other

The mare owner agrees to notify results of pregnancy scans regardless is she is pregnant or not after the 45 day pregnancy scan.

When the Mare Owner signs and returns This Contract to the Stallion Owners including a copy of the Mares' registration papers and the Booking Fee, it will then be a binding contract for both parties' subject to the above terms and conditions. This contract is not transferable or assignable. In the event that the said mare is sold, the Service Fee and any other outstanding fees, shall immediately become due and payable by the undersigned owner. The Service fee is not transferrable.
